
Human rights in Chilliwack

The housing crisis is a human rights issue in Chilliwack

Housing is increasingly unaffordable



Between 2016 and 2021 the media value of a home in Chiliwack increased by 88%. This far exceeds the province wide increase of 57%.

Homelessness is increasing rapidly



From 2020 to 2023, the number of people experiencing homelessness increased from 306 to 413, according to the Homeless Count.

Homelessness is experienced more often by Indigenous people

In 2020, Chilliwack had the highest proportion of homeless people with Indigenous ancestry in the Fraser River Valley at 25 per cent.—

Access to health care is a human rights issue in Chilliwack

Discrimination is a barrier to health care



Indigenous people, people with disabilities, people who speak English as an additional language, people experiencing homelessness and/or people who use substances reported experiencing discrimination when trying to access health care.

Discrimination and hate are human rights issues in Chilliwack

Anti-Indigenous, anti-Black hate and Islamophobia

Indigenous and Black people in Chilliwack reported experiencing regular discrimination in retail settings as well as health care and employment.

Rise of anti-LGBTQ2SAI+ hate in Chilliwack

Participants noted a troubling rise in hate and discrimination against the LGBTQ2SAI+ community, especially directed at gender-diverse and trans youth.

Migrant workers' human rights

In 2022, there were 11,831 temporary foreign workers in the agricultural sector in B.C., most of whom migrated from Mexico. These workers face substandard working and living conditions and have reported experiences of psychological, financial, physical and sexual abuse.
